הקדמה העורך

"מטרת חברות אלו היא להביא לידיית המעוניינים והנוגעים בדבר את הבעיות, הפטורנות והליך המחשבה של רבנים ורופאים שעסוקו בבעיות אלו... ואשר נכתבו במקומות מפוזרים ובלתי ספרתיים לרפואה והלכה".

לכן בנוסף למדורים הקבועים העוסקים בפרסומים מקוריים ובתקצירים בעלי עין, פתחנו בגליון לא-לב של אסיה את המדור הביבליוגרפי. הביבליוגרפיה הראשונה שפורסמה אז באסיה, הייתה בביבליוגרפיה עברית, פרי עטו של פרופ' נחום רקובר, חלק מ"אוצר המשפט" — המפתח הביבליוגרפי למשפט עברי. ה"אוצר" לא כלל הפניה למאמרים בשפות לועזיות למרות המאמרים הרבים שנכתבו בלועזית על נושאי הרפואה וההלכה.

בינתיים השלים פרופ' רקובר את החסר, ולפניו מוגשת בביבליוגרפיה לועזית מקיפה בנושאי הרפואה וההלכה, המתרסמת במקביל בבטאון החדש Jewish Medical Ethics שבhootאתנו. התודה והברכה לפרופ' רקובר, המשנה ליועץ המשפטי לממשלה, שאפשר את פירוטם הפרק הרפואico-הלכתי של ספרות לועזיות, מתוך המהדורה המעודכנת והמורחבת של "אוצר המשפט" העומד לראות אור בקרוב.
